## Camp Check - In

## Monday, June 5 at the Arena at 7:30a.

Jerseys and schedules are handed out. "Teams" are assigned. An orientation (parents invited) and our first full day will follow. **Full equipment is required.**

Please plan on picking up your defenseman promptly at the end of your session. The staff cannot be responsible for supervising the players following the conclusion of your daily activities.

### **Medical Form**

The form can be printed from your **Registration Confirmation email (it was attached).** You can also access on our website (www.mitchkorn.com) under the CAMP FORMS tab. <u>DO NOT MAIL</u> IT BACK. Bring it with you totally completed to Check-In on the first morning. Players cannot skate without it!

#### Snacks/Breaks

During the break time, the arena snack bar will have snacks available. You may bring or buy snacks.

## **Balance of Fees**

Your Registration/Confirmation acceptance was e-mailed to you. Most pay a Tuition Deposit (\$75) to register. The Balance of Fees remain. All Balance of Fees along with a 5% "registration fee on the full tuition" will be charged to the credit card on file on May 6. All fees are in U.S. funds. Any change in credit card account numbers can be revised by logging into the On-Line Registration site and your account which was established when you registered.

#### **Refund Policy**

- All cancellations must be made via phone call or e-mail directly to Mitch Korn.
- All camp tuition (deposit and balance of fees) is accompanied by a 5% "Registration Fee" charged by the on-line service to cover credit card and administrative costs. All "Registration Fees" and your \$75 tuition deposit are non-refundable & non-transferable.
- All "balance of fees" (\$335 balance) will be refunded up to **3 weeks** (21 days) prior to the day camp begins with a written doctor's medical excuse. After that point, 80% of these "balance of fees" will be refunded with notification prior to the **7 DAYS BEFORE** camp begins.
- There is <u>no refund</u> of any fees should a player drop out of camp for any reason within the 7 days before camp begins.
- Should a player be asked to leave camp by the Director for any reason, no refund is made.
- All refunds will be credited back to the family credit card used to register.

#### **Equipment**

Remember, all defensemen must have full, legal equipment. We will provide the on-ice jersey sponsored by <u>CCM</u>. For the classroom session, all defensemen should bring a change of dry clothing.

#### Locker rooms

We expect all players to **RESPECT** this facility, the staff and the other participants. For females participating in the program, separate locker room facilities will be available. All players should be able to dress themselves. Parents, please refrain from entering the locker rooms...space is very tight. Parental assistance is allowed outside the locker rooms, only.

#### The Final Day

We will have an awards ceremony at the end of the final session on <u>Thursday</u>. All the parents are welcome. All players will receive **take home information**, which includes helpful articles for defensemen and parents.
